# **Matters Before The Council**

Below are highlights from the City Council meetings during the months of July, August, and September.

July 25, 2023 – The City Council unanimously approved a Professional Services Agreement with **Be Well OC (Mind OC)** as the service provider for the City's Mobile Crisis Response Team program for mental health services.

July 25, 2023 – The City Council awarded a contract to CEM Construction Corporation for the construction of Project No. CP1287000 – **Anabel – Woodbury Water Improvement Project**.

July 25, 2023 – The City Council unanimously approved a new 15-year lease agreement with the County of Orange for the **Garden Grove Regional Library – Main Library Branch** facility located at 11200 Stanford Avenue.

August 8, 2023 – The City Council approved a Purchase and Sale Agreement with LT Properties, LP for the acquisition of the property located at **12966 Euclid Street in Garden Grove**.

August 22, 2023 – The City Council adopted a proclamation commemorating the **50<sup>th</sup> Anniversary of Sister City Anyang, Korea**.

August 22, 2023 – The City Council awarded a contract to California Landscape and Design Inc. for **capital improvements at Magnolia Park**.

September 12, 2023 – The City Council approved an agreement with the Children and Families Commission of Orange County to receive **\$240,000 in First 5 Program grant funding** for the Engaged Neighborhoods Initiative which will be used to provide early childhood development services at the City's Magnolia Park and Buena Clinton Youth and Family Resource Centers.

September 26, 2023 – The City Council approved an **Exclusive Negotiation Agreement** with Edgemoor/Clark/AC Martin to begin the design development phase on the new Public Safety Building.

# **Legislative Advocacy**

The City Manager's Office coordinates an active legislative advocacy program focused on protecting the interests of our community and identifying resources available to enhance City services and programs. Our legislative efforts include researching and monitoring federal and state legislation, preparing letters and related communications in response to proposed legislation, and working with our legislative representatives and their staff to promote the interests of our community in alignment with the City's Legislative Advocacy Program. ### SUPPORT POSITIONS

### AB 1027 (Petrie-Norris) Fentanyl Trafficking Social Media (Chaptered on 10/13/23)

AB 1027 aims to prevent fentanyl poisoning by enacting more stringent data collection and storage requirements for social media companies to help law enforcement stop online fentanyl sales and address the significant number of opioid-related deaths in California. AB 1027 would require social media companies to post a general description of their policy regarding accounts that have been actioned for drug related offenses in their policy statement and biannual report to the Attorney General. This bill would require social media companies to retain data on actioned content for 90 days.

#### SB 43 (Eggman) Behavioral Health (Chaptered on 10/10/23)

SB 43 seeks to modernize portions of California's behavioral health treatment system and social safety net system to ensure that vulnerable individuals with the most acute needs receive access to the care they need. Specifically, SB 43 modernizes the definition of "gravely disabled" within the Lanternman-Petri-Short Act to include conditions in which individuals experience an inability to provide for their personal safety or necessary medical care as a result of severe substance use disorder or a co-occurring disorder.

#### AB 67 (Muratsuchi) Homeless Courts Pilot Program (Dead)

AB 67 seeks to create a Homeless Courts Pilot Program, which would remain in effect until January 1, 2029, to be administered by the Judicial Council for the purpose of providing comprehensive community-based services to achieve stabilization for, and address the specific legal needs of, chronically homeless individuals who are involved with the criminal justice system. Specifically, this program would allow local jurisdictions to create diversion programs for unhoused individuals charged with infractions, misdemeanors, or low-level, non-violent felonies.

#### SB 363 (Eggman) Facilities for Inpatient/Residential Mental Health/Substance Use Disorder Database (Suspense)

SB 363 seeks to establish a real-time behavioral health bed database. SB 363 would require the State Department of Health Care Services to develop a database by 2026 to collect, aggregate, and display information about beds in inpatient psychiatric facilities, crisis stabilization units, community care facilities, and licensed residential alcoholism or drug abuse recovery or treatment facilities. This information would help provide timely access to care and increase coordination between service settings.

#### AB 1657 (Wicks) The Affordable Housing Bond Act of 2024 (Suspense)

AB 1657 would place a \$10 billion bond measure on the March 2023 ballot to spur the production of affordable and supportive housing development in an effort to get residents off the streets and keep them in their homes.

# **Legislative Advocacy**

### **OPPOSE POSITIONS**

#### AB 1484 (Zbur) Temporary Public Employees (Chaptered on 10/10/23)

AB 1484 mandates that temporary employees be included in the same bargaining unit as permanent employees upon the request of the recognized employee organization. The provisions of this bill would seriously discourage public agencies from hiring temporary employees, effectively reducing temporary employment opportunities statewide and negatively impacting delivery of City services.

#### AB 1637 (Irwin) Website Domain Names (Chaptered on 10/8/23)

AB 1637 would require a local agency that maintains an internet website for use by the public to ensure that the internet website utilizes a ".gov" top-level domain or a ".ca.gov" second-level domain and would require a local agency that maintains an internet website that is noncompliant with that requirement to redirect that internet website to a domain name that does utilize a ".gov" or ".ca.gov" domain (no later than January 1, 2029). This bill would also require a local agency that maintains public email addresses to ensure that each email address provided to its employees utilizes a ".gov" domain name or a ".ca.gov" domain name. By adding to the duties of local officials, AB 1637 would impose a state-mandated local program.

#### AB 504 (Reyes) State and Local Public Employees Labor Relations and Disputes (Vetoed)

AB 504 upends the current bargaining process which allows striking only in specified circumstances. AB 504 would allow local public employees to refuse to enter property that is the site of a primary labor dispute, perform work for an employer involved in a primary labor dispute, or go through or work behind a primary picket line. AB 504 would also prohibit an employer from directing an employee to take those actions, limiting local agencies ability to plan for coverage and take steps to limit impacts on the community.

#### AB 742 (Jackson) Law Enforcement Police Canines (Dead)

AB 742 aims to prohibit the use of an unleashed police canine by a peace officer to arrest or apprehend a person; for crowd control at any assembly, protest, or demonstration; and in any circumstance to bite. AB 742 would restrict law enforcement agencies from utilizing non-lethal options in circumstances that call for a more robust law enforcement response and would limit options for prevention and intervention.

#### AB 309 (Lee) Social Housing Act 2023 (Vetoed)

AB 309 would create the Social Housing Program within the Department of General Services (DGS) to facilitate the construction of government owned housing on leased state property or excess property. While AB 309 intends to produce more housing to address critical issues such as housing affordability and homelessness facing California cities, AB 309 disregards the state mandated planning process and specifically empower DGS to make land use and zoning decisions on state excess property.

#### AB 1490 (Lee) Affordable Housing Development Projects Adaptive Reuse (Chaptered on 10/11/23)

AB1490 would require local jurisdictions to allow developers to adaptively reuse existing residential buildings, and award certain concessions to 100 percent affordable housing projects notwithstanding any inconsistencies between the project and any local plans, zoning, or regulations.

# **Investment Toward Infrastructure**

In line with the City Council's priority of improving the City's aging infrastructure, the City developed and adopted a Five-Year Capital Improvement Plan, committing nearly \$173 million in funding over the next five years to improve citywide capital infrastructure. The Capital Improvement Plan focuses on allocating resources towards the enhancement of city streets, parks, facilities and other essential infrastructure.

# Five Year Capital Improvement Plan Budget

The following major capital improvement projects are currently underway:

## Garden Grove Blvd. Rehabilitation Project – Harbor to Fairview – \$2.05M

The Garden Grove Blvd. Rehabilitation project is nearing completion. The rehabilitation project repaved Garden Grove Blvd. from Harbor to Fairview utilizing \$500k in federal funds. Phase 1 of the project began in May and was completed in June and phase 2 pavement striping has since been completed. Remaining work includes the raising of water valves and manholes to grade.

# Status: 99% Complete Anticipated Completion: November 2023



### Orangewood and Dale Water Improvement Project - \$2.71M

The Orangewood and Dale Water Improvement project is well underway. The project will improve the fire flow in the area bounded by Orangewood Ave and Yorkshire Ave, and Dale Street and Nearing Drive. This water main replacement project will replace over 7,500 ft. of 6-in diameter main line with 8-inch main. In addition, this project will replace 12 of the dry-barrel hydrants with wet barrel hydrants.

Status: 95% Complete Anticipated Completion: October 2023

### Lampson and Lamplighter Sewer Improvement Project – \$2.38M

The Lampson and Lamplighter Sewer Improvement project is nearing completion. This project will redirect sewer flow and eliminate current sewer capacity deficiency along Lenore Avenue, and install approximately 1,100 ft. of new 10-inch sewer pipe in Springdale from Lenore Ave to Lampson Ave and in Lampson Ave from Springdale Street to Lamplighter Street.

Status: 99% Complete Anticipated Completion: October 2023



## Chapman Ave. Rehabilitation & Landscaping Project – Springdale to Western – \$4.19M

The Chapman Ave. Rehabilitation and Landscaping project has made significant progress in Q3. This project will repave Chapman Avenue from Springdale Street to Western Ave. and re-landscape the parkways from Emerald Street to Wild Goose Street. The paving work, including striping, has been completed. The new irrigation system is currently being installed, with landscaping to follow.

# Status: 85% Complete Anticipated Completion: December 2023





### Magnolia Park Capital Improvements - \$557,940

Magnolia Park improvements will include new playground equipment and rubberized playground surface, installation of new outdoor fitness equipment, ADA improvements, replacement picnic shelters, and a replacement fence around the perimeter of the park pool. The new playground will have a citrus theme following the land's history as a citrus farm owned by the Wakeham family. A pre-construction meeting for the project was conducted in September 2023 with demolition and project commencement scheduled for October.

Status: 15% Complete Anticipated Completion: February 2024



### Acacia Neighborhood Street Improvements - \$6.98M

The Acacia Neighborhood Street Improvement project will reconstruct and widen the local streets bounded by Dale, Stanford, Josephine and Garden Grove Blvd. The complete street project will include new curb, gutter, sidewalk, and drive approach improvements, as well as new water laterals to adjacent homeowners. As of July 31, 2023, water service upgrades were 100% complete. Concrete work (sidewalk, curb & gutter, drive approaches, and accessible ramps) was completed on September 29, 2023. The AC pacing process is scheduled to begin early October.

# Status: 35% Complete Anticipated Completion: December 2023





# **Encourage Economic Development**

### **Realty Investment Association of California**

The City's Economic Development & Housing Department partnered with the Community Development Department to co-sponsor a Realty Investment Association of California (RIAOC) meeting held at the City's Community Meeting Center on Tuesday, August 26, 2023. The RIAOC organization is comprised of brokers, investors, and real estate service providers focused on commercial real estate. City departments presented an overview of the Planning and Entitlement Process and incentives offered by the Economic Development and Housing Department.



### Home2 Suites by Hilton

The Home2 Suites by Hilton received a Temporary Certificate of Occupation on Friday, August 18, 2023. The Hilton brand hotel opened on August 24, 2023. The formal grand opening for the hotel is scheduled for October 9, 2023 at 12:00 pm. The Home2 Suites is comprised of 124 rooms, 100 parking spaces, a laundry facility, pool, gym, and lobby area.



### JOBS 1st Program

The City's JOBS 1st Program awarded \$250,000 in loans and grants to local businesses and successfully created/retained ten low-income jobs in Garden Grove.

# **Address Homelessness**

# **Central Cities Navigation Center**

Construction of the Central Cities Navigation Center is in progress, with the goal of providing emergency housing and wrap-around services to individuals experiencing homelessness. As of August 2023, the demolition phase has been completed, design blueprints for CCNC security and IT systems have been finalized, and the Southern California Edison design drawings have been approved. City staff for Garden Grove, Fountain Valley, Westminster, and the CCNC's operator (VOALA) have been actively reviewing and finalizing proposed operations policies and procedures to ensure alignment with the County of Orange Standards of Care.

- Capacity 85 beds (men, women, couples)

Status: 35% Complete Anticipated Completion: Spring 2024

## **Be-Well Mobile Response Team**

Garden Grove's Be-Well Mobile Response Team provides in-community assessment and stabilization for individuals experiencing substance abuse, psychological crises and homelessness. On July 25, 2023, the City Council approved the extension of the Be-Well Mobile Response Team contract for the next 5years. The mobile response team has assisted 7,616 individuals with mobile medical and mental health services since October 2021, which includes 5,182 unsheltered individuals.

- July 436 individuals
- August 416 individuals
- September 452 individuals

# Code Enforcement Staffing Expansion

The City is recruiting for a Code Enforcement Supervisor and Code Enforcement Officer to bolster existing staffing levels. The selection process is currently underway for the Supervisor position and the City is accepting applications for the Officer position. Positions are expected to be filled no later than early 2024. Upon recruitment, the City's Code Enforcement volunteer program will be reinstituted to assist with neighborhood outreach and case follow-up.




# Transient Occupancy Tax

Transient Occupancy Tax (commonly known as the hotel tax or TOT) in July 2023 achieved another historical high with a total collection of \$3.23 million. This figure represents a 4.6% increase from last July. The graph below illustrates a five year comparison of tax revenue by month, clearly highlighting July as the highest performing month on a consistent basis.



# **Investment Activities**

The City continues to grow its portfolio. As of July 31, 2023, total portfolio reached \$406.4 million, among which 83% is invested in securities as shown on the graph. Diversification has been reached to secure safety, liquidity and yield. Weighted average yield was 2.8% and average maturity is about 1.9 years as of July 31, 2023. Estimated annual interest income for Fiscal Year 2023-24 will reach \$11.3 million.



# Purchasing Activities

Since the beginning of Fiscal Year 2023-24, a total of 1,293 purchase orders were issued. Among which, 234 were blanket purchase orders, and 152 were for contracts. Additionally, a total of 6 formal bids were launched. # **Community Outreach**

# **Community Events and Programs**

### Magnolia Park Summer Day Camp Program

Magnolia Park FRC offered a three week summer program for children 1st to 6th grade. Each week activities where related to a specific theme such as the Wild Wild West, Happiest Week of Summer, and Out of this World. This year a physical fitness component was added in collaboration with the non-profit running group, Lightning Youth Academy.

### Buena Clinton Lucha Libre Event

On July 27, 2023, the Buena Clinton Youth and Family Center hosted the first lucha libre event. Over 250 participants enjoyed the evening that included dinner, a resource fair, crafts, raffles, and four lucha libre matches. Participants also had the opportunity to interact and take photos with luchadors.

### Back-2-School Drive

Every child deserves an opportunity to succeed in their education and school supplies enable them to be well prepared to learn. With families struggling financially, the "Back-2-School" program was able to provide assistance with backpacks and school supplies to 121 families, a total of 259 students from Buena Clinton and Magnolia Park Family Resource Centers.

### H. Louis Lake Senior Center Resource Fair

The H. Louis Lake Senior Center's Resource Fair and Vaccine Clinic was held on Wednesday, September 20, from 10:00 a.m. to 1:00 p.m. Attendees received free giveaways from participating vendors, and were able to access vaccinations for shingles, RSV vaccine, TDAP, Hep B, flu, pneumonia, and COVID. Vaccinations were offered through a partnership with Albertson's Pharmacy. Additional event activities included opportunity drawings, music, and a free meal.

#### Summer Concert Series

In partnership with the Garden Grove Community Foundation, the City offered a total of six (6) free summer concerts. # **Residential Truck-Mounted Treatments**

Reducing the population of adult mosquitoes with public health pesticides (adulticides) that are registered by the US Environmental Protection Agency (US EPA) will be done if necessary to prevent human illness or suppress a heavy nuisance infestation of mosquitoes. The decision to use mosquito control applications either by truck-mounted, backpack or aircraft application equipment will be based on surveillance information or the documentation of **West Nile virus or** 

other mosquito-borne disease activity at a level that indicates a threat to human health. Either Adulticiding (ULV) or Larvicide (WALS) will be concentrated in areas most at risk for disease occurrence or where travel-related mosquito-borne disease cases have been identified.

If weather conditions are not favorable, or if there are operational delays, the

treatment may be postponed or delayed. Treatments may continue or resume in the following weeks with continued West Nile virus or other mosquito-borne disease activity.

#### GARDEN GROVE TO PARTICIPATE IN NATIONAL PRESCRIPTION DRUG TAKE BACK DAY

On Saturday, October 28, 2023, from 10:00 a.m. to 2:00 p.m., the Garden Grove Police Department will participate in the Drug Enforcement Administration's (DEA) National Prescription Drug Take Back Day. The event gives the public an opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to the Garden Grove Police Department, located at 11301 Acacia Parkway, Garden Grove 92842. (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

This April, Americans turned in 332 tons (over 663,700 pounds) of prescription drugs at over 4,900 sites operated by the DEA and its state and local law enforcement partners.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies have shown that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

#### MULTI-STREET CONSTRUCTION PROJECT UNDERWAY FOR NEW BIKE LANES

As part of the City of Garden Grove's commitment to improve active transportation and implement community-identified goals, bike lanes will be added along five major streets as part of the Bicycle Corridor Improvement Project (BCIP). The BCIP is a federal program that provides funding for projects that make bicycling and walking easier and safer in Orange County. The Garden Grove project originated from the City's Re:Imagine Garden Grove initiative and Medal of Honor Bike and Pedestrian trail to create more walkable and bike-friendly areas in the city. Streets under construction and tentative project dates are:

- West Street, from Garden Grove Boulevard to Orangewood Avenue, now through Friday, October 27;
- Brookhurst Street, from Trask Avenue to Katella Avenue, now through Wednesday, November 1;
- Gilbert Street, from Deodora Drive/Westminster Boulevard to Katella Avenue, now through Thursday, November 9;
- Lampson Avenue, from Dale Street to Haster Street, from Friday, October 27 through Tuesday, November 21; and
- Chapman Avenue, from Valley View Street to Beach Boulevard, recently completed.

Multi-Street Construction Project Underway for New Bike Lanes 2-2-2

Work hours are 7:30 a.m. to 4:00 p.m., Monday through Friday, for West Street and Gilbert Street. For Chapman Avenue, Brookhurst Street, and Lampson Avenue, work hours are 9:00 p.m. to 5:00 a.m., Monday through Friday.

Residents and business owners along the construction areas have been notified in advance through flyers delivered door-to-door.

Residents are asked to follow temporary "No Parking" signs and expect heightened traffic and noise due to construction activities. Access to residences, businesses, and schools will be maintained at all times.

Construction work includes road-rebalancing and adding stripping buffers, bike loops, wayfinding signage, and video detection camera systems.

The BCIP is funded by the Congestion Mitigation and Air Quality Improvement Program that supports projects that meet Federal Clean Air Act requirements.

#### COMMUNITY MEETINGS CONTINUE FOR ORGANICS RECYCLING PROGRAM

Residents living in multi-family properties, such as apartments and condominiums, are invited to attend a community meeting to learn about the state-mandated Organics Recycling program. Meetings will be held on Wednesday, November 1 at 6:00 p.m., at the Garden Grove Community Meeting Center, at 11300 Stanford Avenue, and Tuesday, November 14 at 10:00 a.m., at the Buena Clinton Youth and Family Center, at 12661 Sunswept Avenue. Both meetings will provide the same information. Spanish, Vietnamese, and Korean interpreters will be available at the November 1 meeting, and the November 14 meeting will be conducted in Vietnamese only.

Discussion topics include the state's organic waste recycling law, SB 1383, and the importance of organics recycling; waste collection service changes; proper separation of organic waste; and steps to mitigate unwanted pests and smells.

Attendees will receive a free kitchen pail used to collect food scraps prior to emptying into recycling containers.

Implemented in 2022, the City's Organics Recycling program was created in response to California State Law SB 1383, requiring a reduction of organic waste in landfills to reduce emissions of harmful environmental pollutants. SB 1383 requires non-compliant accounts to be fined starting in 2024.

#### \$1.9m to fight encampments

October 24



The appropriation of \$1.9 million in state grant money to clean up homeless encampment areas in the city and move the occupants into permanent housing was approved by the Garden Grove City Council on Tuesday night.



The city manager is authorized to execute a memorandum of

understanding with the County of Orange for the use of what's called the Encampment Grant Resolution Round 3 Lookback.

According to a staff report, the areas to be targeted – based on calls for service and incidents of violent incidents – are four locations along the Garden Grove Freeway, at Beach Boulevard, Euclid Street, Newhope Street and Haster Street.

Funding will go to operations of the Central Cities Navigation Center (\$500,000), the GGPD's Special Resource Team (\$150,000 annually for three years), OC Office Care Coordination (\$165,000 twice) and to the BeWell Mobile Response Team (\$200,000, \$175,000, and \$175,000 over the three years).

Withdrawn from the agenda was an item calling for the issuance of a purchase order for \$1.2 million for a new mobile police department command force.

The next council meeting is scheduled for Tuesday, Nov. 14.

#### **Enhancements for Grove trail**

Joggers, bicyclists, strollers and nature-lovers, rejoice.

A grant of \$441,000 has been awarded to the City of Garden Grove for enhancements to the Medal of Trail that runs from Nelson Street northwest to Brookhurst Street along the old Pacific Electric right-of-way.



The grant from the "Clean California" project of the California Department of Transportation (CalTrans) will go toward providing new trash receptacles, new benches, new bicycle racks and over 120,000 square feet of mulch at various locations throughout the trail corridor which will also prevent water runoff and flooding as well as add longevity to the recently-added 363 trees and landscaping.

Adding mulch is also intended to help reduce the "urban heat island" effect. The project will also see added 22 new pieces of fitness equipment.

That's not the only change coming for the trail. In August, the announcement was made that \$750,000 in federal funding has been allocated for the "Santa Ana-Garden Grove Rails to Trails Gap Closure Project," which will extend the Medal of Honor trial southeast to link up with the Santa Ana River Trail which runs north to Orange and south to Huntington Beach.

When completed, it would allow people to bike or walk to the Santa Ana Transportation Center or board the under-construction OC Streetcar.

## Garden Grove sẽ cải tiến đường mòn cho người đi bộ và xe đạp

October 15

**GARDEN GROVE, California (NV)** – Thành phố Garden Grove nhận được hơn \$400,000 từ tiểu bang California để cải tiến đường mòn cho người đi bộ và xe đạp.

Theo báo mạng Orange County Tribune, Garden Grove nhận được \$441,000 từ Sở Giao Thông California, còn gọi là CalTrans, để cải tiến đường mòn Huân Chương Danh Dự chạy từ đường Nelson đến đường Brookhurst.

Số tiền này sẽ được sử dụng để đặt nhiều thùng rác mới, băng ghế mới và các chỗ khóa xe đạp mới. Thành phố còn sẽ rải thêm 120,000 sq ft lớp phủ cây cỏ dọc theo đường mòn để chặn nước chảy lên đường mòn và giúp bảo vệ 363 cây mới trồng.

Việc rải lớp phủ còn giúp giảm hiệu ứng "đảo nhiệt đô thị," có nghĩa là khu vực đô thị nóng hơn các vùng ngoại ô.

Không chỉ vậy, dự án này còn giúp thành phố đặt thêm 22 thiết bị tập thể dục trên đường mòn.

Vào Tháng Tám vừa qua, liên bang thông báo cung cấp \$750,000 cho các dự án đường mòn ở Garden Grove và Santa Ana để mở rộng đường mòn Huân Chương Danh Dự của Garden Grove, kết nối vào đường mòn sông Santa Ana đi hướng Bắc đến Orange và đi hướng Nam đến Huntington Beach.

Sau khi hoàn tất, cư dân có thể đi bộ hay đạp xe đến Trung Tâm Giao Thông Santa Ana bằng đường mòn hoặc có thể đón xe điện OC Streetcar đang xây dựng.

## Cảnh sát Westminster và Garden Grove bác tin đồn `cướp giật lộng hành Little Saigon'

**LITTLE SAIGON, California (NV)** – Một ngày sau khi nhật báo Người Việt đăng bài phóng sự điều tra <u>"Trộm cướp lộng hành Little Saigon,' chuyện bia như thật!,</u>" hai sở cảnh sát ở Westminster và Garden Grove, hai thành phố có nhiều doanh nghiệp và cư dân gốc Việt cư ngụ, lên tiếng bác bỏ các tin đồn do một số cá nhân đưa lên mạng xã hội và truyền thông, cho rằng nhiều nhà hàng và tiệm thuốc tây Việt Nam bị cướp, thậm chí bắt con tin, trong thời gian qua.

Trên Facebook hôm Thứ Tư, 18 Tháng Mười, Sở Cảnh Sát Westminster cho biết: "Gần đây, chúng tôi có biết một số mạng xã hội đưa lên và chia sẻ một số câu chuyện là có cướp bóc tại một số nhà hàng và tiệm thuốc tây trong khu vực Westminster và Garden Grove."

"Sau khi kiểm tra với các đối tác địa phương tại Sở Cảnh Sát Garden Grove, chúng tôi thấy không có bằng chứng nào cho thấy những chuyện này xảy ra, hoặc bất cứ báo cáo nào cho thấy có cướp bóc xảy ra. Thông tin này cũng được kiểm chứng với các doanh nghiệp được mạng xã hội cho là bị cướp bóc," cảnh sát Westminster cho biết tiếp. "Các doanh nghiệp này khẳng định họ không hề bị cướp bóc gì cả. Cảnh sát Westminster không hề biết tại sao những người này lại tung các tin này ra, cũng như chúng tôi cũng không biết nguồn gốc của các tin này."

Cảnh sát Westminster cho biết thêm: "Mục tiêu của chúng tôi là kịp thời thông báo cho công chúng biết bất cứ tội phạm nào xảy ra. Dựa trên những gì thu thập được liên quan đến những gì viết trên mạng xã hội (về chuyện cướp bóc ở Little Saigon), chúng tôi khẳng định những điều này không thể chứng minh được."

Hôm Thứ Ba, trên Facebook, Sở Cảnh Sát Garden cũng đề cập việc này.

"Cảnh sát Garden Grove có biết, mới đây, một số người đưa lên mạng xã hội và chuyển cho nhiều người về một loạt vụ cướp trong các nhà hàng và tiệm thuốc tây ở Garden Grove," theo cảnh sát Garden Grove. "Sau khi làm việc với Sở Cảnh Sát Westminster và nói chuyện với một số doanh nghiệp, chúng tôi phát hiện những thông tin này là không thể chứng minh được. Chúng tôi cũng không biết nguyên do và nguồn gốc của các thông tin này trên mạng xã hội."

Cảnh sát Garden Grove thêm: "Chúng tôi trân trọng cộng đồng kịp thời báo cho chúng tôi biết vấn đề này. Xin quý vị tiếp tục tỉnh táo và báo cho chúng tôi biết những gì bất thường xảy ra."

Trên trang Facebook của cảnh sát Westminster có một số người viết bày tỏ ý kiến của mình, và có hai người đề cập đến một nhân vật khá nổi tiếng trong cộng đồng Việt Nam.

Một trong hai Facebooker này, có tên Quốc Trần, viết: "Giới chức chính quyền nên để ý chuyện này, rằng tin giả về 'cướp bóc hàng loạt' ở Orange County được tạo ra với mục đích chính trị, đó là gởi ra một thông điệp rằng các chính sách của Tổng Thống Joe Biden tệ hại cho Westminster và cho cả nước Mỹ."

"Tôi chắc chắn đây là một cuộc vận động có sự phối hợp, nhiều phần do những người ủng hộ ông Donald Trump thực hiện," Facebooker này viết tiếp. "Tôi biết một cá nhân cụ thể, người cố tình truyền bá những tuyên truyền giả dối này, và là một người khá nổi tiếng ở Little Saigon (Anh có kênh YouTube và cũng có bán các sản phẩm trên các đài truyền hình tiếng Việt)."

Little Saigon, tọa lạc tại Orange County, miền Nam California, là nơi có nhiều người Mỹ gốc Việt nhất hải ngoại, phần lớn sinh sống trong bốn thành phố Fountain Valley, Garden Grove, Santa Ana, và Westminster, và có nhiều doanh nghiệp do người Việt làm chủ. **(Đ.D.)** 

## 'Trộm cướp lộng hành Little Saigon,' chuyện bịa như thật!

October 18



**WESTMINSTER, California (NV)** – Theo tin "Thông Tấn Xã Bolsa," trong thời gian gần đây, tệ nạn trộm cướp tăng vọt tại Little Saigon đến nỗi tuần trước, cướp xông vô nhà hàng Vân, nhà hàng Tràm Chim, và một số nhà hàng khác vùng Little Saigon giật đồ của thực khách.

Little Saigon là nơi có cộng đồng người Việt lớn nhất hải ngoại.

Hôm Thứ Hai, 16 Tháng Mười, một Facebooker tên Ken Tran còn viết (nguyên văn): "Mọi người cẩn thận hiện tại bọn xấu qua cướp nhà hàng in OC. Cướp bắt khách hàng nộp nữ trang, tiền bạc, những gì quý giá tại nhà hàng.... (tên năm nhà hàng ở Little Saigon và một số tiệm thuốc tây)."

"Hôm nay quán Mii ở Bolsa mới bị cướp lúc 3:00 pm. Yes. Cướp lúc 3:00 pm mà hold up tới 4:00 pm mới thả con tin," Facebooker này viết tiếp. "(Viết bằng tiếng Anh) Mọi người bây giờ nên cẩn thận. Kẻ xấu đang cướp nhà hàng ở OC..."

Phóng viên Người Việt làm một cuộc "điều tra" thì mới biết các nguồn tin trên không dựa trên sự thật mà nảy sinh từ trí tưởng tượng phong phú của một "tiểu thuyết gia thất nghiệp" nào đó.

Hôm Thứ Ba, 17 Tháng Mười, khi được hỏi chuyện cướp lúc 3 giờ và giữ con tin tới 4 giờ mới thả, ông Mỹ Ngô, chủ nhân hai nhà hàng Mii, một ở trong khu Bolsa Mini Mall, Garden Grove, và một ở góc đường Edinger và đường Brookhurst, Fountain Valley, cười phá lên và nói: "Làm gì có chuyện đó. Cái này là do cái tụi Facebook đăng tầm bậy tầm bạ. Mà không chỉ có quán tôi bị đăng mà còn các quán khác nữa trong vùng Little Saigon cũng bị."

"Có mấy người hỏi tôi vụ này chứ không phải chỉ có nhà báo. Anh thử nghĩ coi, nếu có chuyện này xảy ra thì hàng chục xe cảnh sát đã có mặt, trực thăng bay vù vù trên trời, truyền thông Mỹ đến đưa tin rần rần, cả Little Saigon này ồn ào rồi," ông Mỹ nói tiếp.

Ông Mỹ cho rằng đồn đãi kiểu này rất nguy hiểm, ảnh hưởng cả cộng đồng, không chỉ nhà hàng của ông mà cả các nhà hàng khác trong vùng.

"Cứ đồn đãi kiểu này thì ai dám đến ăn các nhà hàng Việt Nam, ảnh hưởng cả vùng Little Saigon. 'Fake news' (tin giả) kiểu này tai hại vô cùng. Các anh là nhà báo làm ơn giúp chúng tôi với," ông Mỹ nói với nhật báo Người Việt.

Lúc 11 giờ 34 phút sáng Thứ Hai, 16 Tháng Mười, phóng viên người Việt liên lạc nhà hàng Tràm Chim trên đường Bolsa, Westminster, thì được một phụ nữ giọng pha âm hưởng miền Trung bực bội nói: "Không hề có chuyện đó xảy ra ở bất cứ tiệm Tràm Chim nào."

Khi được hỏi tên, phụ nữ này tỏ vẻ không bằng lòng hơn nữa và trở giọng cộc lốc: "Nếu cần 'order' đồ ăn thì chúng tôi hỗ trợ còn chuyện khác thì chúng tôi không giải quyết."

Khác hẳn với thái độ hậm hực của Tràm Chim, bà Hương Trần ở nhà hàng Vân, trên đường Brookhurst, Garden Grove, cười vồn vã: "`Tin tức Facebook' đó anh. Trời ơi, ai mà đồn ác quá, làm khách không dám tới đây sao? Không có đâu anh. Không hề có chuyện đó xảy ra ở đây đâu."

Bà cho biết bà vừa được một thực khách quen cho đọc tin đồn này trên Facebook.

Nhà hàng Vân vốn nổi tiếng vì nhiều món ngon, đặc biệt nhất là bánh xèo và canh mồng tơi riêu cua.

Các cư dân tại Little Saigon cũng lắc đầu khi được hỏi ý kiến về hai vụ giật đồ này. Ông Hải Lưu, ở Westminster, cười tinh quái: "Tôi dám nói đoán chắc đây là 'tin bô lão,' do các cụ mùa này không được về Việt Nam để xả nổ. Ở đây buồn nên tự nghĩ ra thôi. Đây là tình trạng chung. Tôi có ông chú 'giang hồ.' Mới tháng trước ông đi Las Vegas với tôi. Thấy ông thua \$50 rồi buồn bã, tôi cho ông \$40 cho vui. Về tới đây, ông khoe bạn bè là ông thắng \$2,000 và cho tôi \$500 làm tôi hết hồn."

"Cũng như vụ cướp tiệm vàng Ngọc Quang, chắc được vài cây vàng mà thiên hạ trên Facebook dám đồn tới 2,500 cây," ông cười to. "Chắc mấy cụ thấy có lạm phát nên tự động bù thêm cho bọn cướp."

Bà Rose Nguyễn, ở Garden Grove, nói: "Tôi quen nhiều cô bán hàng ở quanh vùng này lắm. Có chuyện như vậy là mấy cô nói ầm ầm rồi, mà tôi có nghe gì đâu. Có vụ đó hả?"

Một ông chỉ cho biết tên là Steven nói: "Chuyện này là do các cụ già 'nổ' đó. Ba má tui cũng vậy đó. Không lừa gạt ai đồng cắc nào nhưng mà khoái 'nổ.' Bữa đó, tôi vừa đi làm về thì hai người nói với tui là ông George gần nhà vừa bán hai con chó nhỏ mới đẻ, mỗi con \$1,200. Tôi ngạc nhiên vì ba má tui đâu có nói tiếng Anh mà trong xóm thì không có ai Việt Nam. Tôi lò dò qua hỏi thăm thì 'té ngửa' là con chó nhà ông George là chó đực."

Ông Steven vừa cười vừa lắc đầu trước nguồn tin của "Thông Tấn Xã Bolsa."

Khi được hỏi về chuyện cướp giật trong nhà hàng, Trung Sĩ Phương Phạm, phát ngôn viên Sở Cảnh Sát Westminster, cho biết ông không hề hay biết gì về chuyện này.

Tuy nhiên, ông chia sẻ rằng chuyện trộm cướp thì ở đâu cũng có và lúc nào cũng có.

"Như người ta vẫn biết, những nguồn tin loan tải trên mạng thông tin xã hội thường là thổi phồng chứ không chính xác. Trên thực tế, so với năm ngoái, trong ba tháng Tư, Năm và Sáu năm nay, nạn cướp giật tại Westminster giảm 46%."

Ông Phương nhắc: "Nếu cứ nghe tin đồn thì chuyện gì cũng ghê gớm lắm trong lúc thực tế hoàn toàn khác hẳn. Trộm cướp, như tôi đã nói thì có, nhưng không như tin đồn vô căn cứ. Trở lại chuyện cướp trong nhà hàng thì trong mấy năm nay là không có."

Ông Phương cũng cho biết thêm là những vụ cướp giật ở Westminster trước đây là do băng đảng ở nơi khác đến.

"Họ có thể ở Los Angeles hoặc nơi khác chứ không phải dân địa phương," ông nói.

#### Những điều có thật

Mấy năm trước, Little Saigon từng xảy ra một loạt vụ giật đồ lặt vặt. Như hồi Tháng Năm, 2017, có một vụ giật dây chuyền ở tiệm Nước Mía-Hột Vịt Lộn Long An trong khu chợ ABC trên đường Bolsa, Westminster.

Đây là vụ thứ ba liên tiếp trong vòng một tuần qua về nạn giật dây chuyền xảy ở khu vực Little Saigon.

Lúc ấy, cảnh sát viên Westminster nhận xét: "Những người (nghi can) này thường để ý vào phụ nữ Việt Nam lớn tuổi nhiều hơn, vì vậy những người lớn tuổi nên để ý khi ra đường."

Sau đó, vào Tháng Năm, 2019, một vụ cướp giật khác xảy ra tại khu thương mại Garden Grove Plaza, góc đường Westminster và Brookhurst, thuộc thành phố Garden Grove làm một phụ nữ gốc Việt thiệt mạng. Cảnh sát sau đó bắt giữ ba nghi can.

Từ đó đến nay, Little Saigon không có vụ giật đồ thật sự nào nữa.



# Court provides clarity on historical resource CEQA exemptions

Oct 18, 2023

A California appellate court on Oct. 6 published a favorable ruling on environmental review exemptions, meaning cities can now rely on the opinion as precedent. The move came at the <u>urging</u> of the League of the California Cities and the city of Glendale. The case centered on Laguna Beach's approval of a historic home remodel. The city found the project was exempt from the state's environmental review process because it complied with federal standards for rehabilitating historic buildings.

The court did not publish the initial ruling in September, meaning it would have had no precedential effect on other cases.

#### Case history and outcome

Most projects that may cause a substantial, adverse change to the significance of a historical resource must undergo an environmental review under the California Environmental Quality Act (CEQA). However, some projects are exempt from review, including "Class 31" projects. Such projects are focused on maintenance, restoration, or reconstruction. This exemption kicks in when a project meets the U.S. Secretary of the Interior's Standards for the Treatment of Historic Properties.

The local Historic Architecture Alliance sued Laguna Beach in 2021 for its approval of an addition to a historic, two-story home. The association alleged that the city's finding that the project complied with federal standards was not sufficient for a Class 31 exemption. The association said it made a "fair argument" that the project would still result in a substantial, adverse change to the house. Therefore, the city needed to conduct an environmental review under CEQA.

The court disagreed and issued a ruling clarifying that when a project follows the Secretary's standards, it necessarily has a "less than significant" effect on the historical resource. It is not enough for a challenger to make a "fair argument" that the project will result in a substantial, adverse change. Rather, the Class 31 exemption applies so long as substantial evidence supports the city's determination that the project meets the Secretary's standards, which the court found it did in this case.

Gillian Van Muyden (Glendale City Attorney's Office) drafted the request for publication for Historic Architecture Alliance v. City of Laguna Beach. This article is for general informational purposes only. Cities with questions about the specific impact of this ruling on their city should consult their city attorney.



# The good, the bad, and what to watch. Newsom's final bill actions

Oct 18, 2023

For a moment it looked like 2023 might be the year of no, as Gov. Gavin Newsom vetoed <u>one measure after another</u>. But then things shifted last week. In the end, Newsom maintained his usual <u>veto rate of 14%</u> — and his promise to halt bills with unaccounted costs. According to *Politico*, the Governor cited budget concerns in 64 of his 156 vetoes.

So, how did cities fare overall, especially in the final week? For cities, it was a good year. Cities did not win <u>every fight</u>. <u>But they</u> won <u>a lot</u> of <u>important</u> battles <u>and</u> laid the <u>groundwork</u> for <u>future advocacy</u> efforts.

Below are the most important measures that the Governor signed and didn't sign last week. The League of California Cities also has a list of every tracked bill <u>signed by the</u> <u>Governor</u>.

The good

California's behavioral health system is set to undergo more changes with the Governor's signature of <u>SB 326 (Eggman)</u>, one of the most watched bills this year. The measure will modernize the Mental Health Services Act to prioritize investments in housing interventions for individuals experiencing homelessness or at risk of homelessness.

Cal Cities attended the bill's <u>signing ceremony</u> last week. In 2022, the Cal Cities Board of Directors <u>adopted a new policy</u> that allowed the organization to take a more active role in advocating for better behavioral health services statewide, especially for unsheltered individuals.

Speaking of last year's business: The Governor signed <u>AB 1526 (Committee on Natural Resources)</u>. This measure will create a mechanism and schedule for plastic producers to remit funds to local governments for costs associated with implementing a landmark single-use plastics law, <u>SB 54 (Allen, 2022)</u>. Time constraints prevented Sen. Ben Allen from adding the agreed-upon language to the bill last year.

The Governor also signed four key public safety measures: <u>AB 40 (Rodriguez)</u>, <u>AB 33 (Bains)</u>, <u>SB 19 (Seyarto)</u>, and <u>AB 1448 (Wallis)</u>.

AB 40 will address a longstanding issue: lengthy ambulance offload times.

Approximately 70,000 Californians wait <u>over an hour</u> to be moved to a hospital bed. This delay can lead to poor care, increased morbidity, and even mortality. AB 40 will create a statewide standard for ambulance patient offload times and require a protocol to reduce offload time if needed.

The other three bills focus on curbing illicit drugs. AB 33 and SB 19 will establish a multisector task force to address fentanyl addiction and overdoses. AB 1448 will incentivize cities to take enforcement actions against illicit cannabis operations by

providing a 50/50 split of the statutory penalties recovered in actions brought by local jurisdictions.

#### The bad

No one bats a perfect game in politics. Cal Cities had a handful of setbacks this year. But when it comes to bad bills for cities, most failed to reach the Governor's desk. Many that did make it to his desk were then vetoed.

One notable bill that did make it through was <u>SB 423 (Wiener)</u>. The measure will extend a <u>2017 streamlined permitting law</u> to coastal cities and move the law's sunset date to 2036. Cal Cities opposed the bill from the start since it may override stated-mandated housing plans and local building requirements. Under the new law, the Department of General Services can determine building standards on state-owned or -leased land. In a related <u>press release</u>, Newsom reiterated his pledge to "[hold cities] accountable to plan for and permit their fair share of housing."

The Governor signed 56 housing bills this year. Many of these measures nibble around the edges and fail to address the significant challenges facing the housing market, such as high interest rates, the inability to finance projects, a lack of qualified buyers, increased costs of construction, and a limited labor force.

#### What to watch

California's water — or lack thereof — has become a key concern for lawmakers. It's unsurprising then that the Governor signed one low-hanging fruit into law: Last year's temporary restriction on using potable water to irrigate non-functional grass is now permanent.

According to <u>state agencies</u>, the yearly use of potable water to irrigate non-functional grass is equivalent to the water usage of 780,000 households. Public agencies must comply with <u>AB 1572 (Friedman)</u> by Jan. 1, 2027. Commercial, industrial, and institutional properties must comply by 2028. Cal Cities had a neutral if amended position for AB 1572.

Cal Cities and several water associations secured changes that give disadvantaged communities more time to comply with the new law. Disadvantaged communities must comply by Jan. 1, 2031, or when a state funding source is available — whichever is later.

The move comes as the state begins crafting <u>new regulations</u> that would reduce water usage in most communities from 2025 onward.

The Governor also signed <u>AB 531 (Irwin)</u>, a companion bill to <u>SB 326 (Eggman)</u>. AB 531 will place a \$6.38 billion bond on the March 2024 ballot for new community behavioral health beds and supportive housing. The bond measure includes \$1.5 billion specifically to help cities and counties.

Cal Cities removed its support for AB 531 after lawmakers introduced concerning, by right approval amendments one week before the session ended.

#### But wait, there's more

It's not over until it's over. California's legislative cycle lasts two years. This means that some "dead" bills could come back to life next year. This includes measures that would restrict the usage of <u>police canines</u>, <u>a statewide tax on short-term rentals</u>, and several Cal Cities-sponsored measures.

There's also a possibility that last-minute tax receipts could lead to a 2023-24 budget revision next year. The Internal Revenue Service extended the filing deadline a second time for Californians impacted by winter 2022's severe storms. The state generally follows the same deadlines as the federal government.

As for what Cal Cities will focus on next year: That's for you to decide. Hundreds of city officials from throughout California will convene in Carlsbad later this year to determine Cal Cities 2024 Advocacy Priorities. Key to those efforts is Cal Cities' <u>annual member</u> <u>survey</u>, which the Cal Cities Board uses to develop member-informed legislative priorities.

# modernization

Long-term funding for behavioral health housing and treatment will go on the March 2024 ballot



The League of California Cities was once again in the limelight for its behavioral health and housing advocacy. Late last week, Gov. Gavin Newsom signed SB 326 (Eggman) and AB 531 (Irwin) into law at a signing ceremony in Los Angeles attended by Cal Cities staff, along with the mayors of Riverside, Sacramento, Los Angeles and Long Beach, over a dozen state



lawmakers, and other key stakeholders.

Cal Cities supported the two bills as part of an effort to secure ongoing funding to address the homelessness crisis. Cities across the state are weaving together limited funding to develop creative solutions that prevent and reduce homelessness.

The two-part legislative package will modernize the Mental Health Services Act and provide long-term funding for behavioral health beds. The package also includes a \$6.38 billion bond for thousands of new community behavioral health beds and supportive housing. In a win for cities, the bond measure targets \$1.5 billion specifically to help cities and counties fund new treatment beds.



Sections of AB 531 and SB 326 will appear on the March 2024

primary election ballot as Proposition 1.

After the ceremony, the Governor announced the California Mental Health Movement, a sweeping plan to address the mental health and substance use disorder crises. The plan focuses on four key pillars: housing, services, workforce, and children. Cal Cities looks forward to working with the Governor and Legislature to support California's most vulnerable residents.



# Cal Cities-sponsored bond agency issues over \$20 million in tax-exempt, multifamily affordable bonds for housing

The California Statewide Communities Development Authority (CSCDA) issued \$20,013,627 in tax-exempt, multifamily affordable housing bonds for the city of Oxnard.

Casa Aliento Apartments is the new construction of 70 housing units — 69 studio apartments and one manager's unit. The apartments will be rent-restricted for extremely low-income individuals, people experiencing homelessness, and households earning less than 30% of the area median income.

CSCDA worked with Oxnard and others to provide the housing bonds. The financing for the apartments requires the affordability of units for extremely low-income tenants to be maintained for 55 years.

# Cal Cities reaffirms support for DACA

# program

Oct 25, 2023

A federal ruling in mid-September prompted the League of California Cities to submit a letter to Congress reaffirming support for the Deferred Action for Childhood Arrivals (DACA) program. Authored by Cal Cities President Dan Parra, the letter notes that a piecemeal approach does not work and creates fear for thousands of Californians. A federal court in Southern Texas issued the decision declaring the federal regulation that created DACA unlawful. The court barred the U.S. Department of Homeland Security from approving new applications.

However, the judge maintained a partial stay of the order for current DACA recipients, known as "Dreamers." People who received DACA status before July 16, 2021 — the date of the original injunction — can still renew their DACA applications. The decision is the latest in a multiyear saga that has created significant uncertainty about the future of this successful program.

Over the last decade, DACA enabled over 900,000 immigrants to stay in the U.S., attend school, and contribute to the economy. According to KFF, a nonpartisan thinktank, over one in four "active DACA recipients" live in California. "The inability of Congress to enact comprehensive immigration reform policies has left states and localities on their own to respond to immigration-related issues that have many human, economic, and societal impacts," wrote Cal Cities President Dan Parra.

In 2018, the Cal Cities Latino Caucus brought a resolution to the Cal Cities Board of Directors in support of DACA. Championed by Parra — then the president of the Latino Caucus — the resolution expressed support for laws that allow existing Dreamers with no serious criminal convictions, including teens and young adults, to remain in the country without fear of removal.

The Board adopted the resolution. Since then, Cal Cities and the National League of Cities have advocated for comprehensive legislative solutions. The latest letter urges Congress to pass meaningful and thoughtful laws that address the realities facing families, students, and workers in California and throughout the country.

# Cities and state agencies advance water

#### efficiency efforts Oct 25, 2023

Cities and state agencies are both advancing water efficiency goals. At the center of these efforts are draft regulations that would create long-term water conservation targets for 400 urban water suppliers statewide, including 200 cities. With California swinging from one extreme weather event to the next, the state is looking at various ways to cultivate long-term water conservation. The goal is to make conservation a way of life and lessen the need for emergency water reductions during droughts.

The draft regulations are part of a 2018 legislative package. On Oct. 17, the League of California Cities submitted comments to the State Water Resources Control Board requesting flexibility for cities. The proposed changes are in line with the legislative package's original timeline.

Many cities are making progress toward true water savings. However, many cities and urban water suppliers also need time to implement the regulations in a way that is feasible and achievable. Currently, the proposed rules raise affordability, administrative, and reporting concerns — especially for smaller communities.

The state is seeking to conserve approximately 500,000 acre-feet each year by 2030. An acre-foot is equal to the size of a football field covered in 1 foot of standing water.

#### State partnerships can help bridge critical resource gaps

As with any big regulatory change, partnerships and funding are the key to success. In mid-October, the Department of Water Resources awarded \$19.1 million in grant funding to support the city of Los Angeles' water efficiency efforts in disadvantaged communities and expand water recycling in the region.

The project infuses \$14.6 million into an existing turf replacement program for homeowners in underserved areas that could save millions of gallons of water each year. The rest of the grant funding will go to a recycled water pipeline. Officials expect the pipeline to provide 3.5 million gallons of drinking water per day to 47,000 Angelenos.

Efforts like these need to happen throughout California for the state to meet its water conservation goals. Cal Cities will continue to work with the state to ensure any proposed regulations can be successfully implemented at the local level.

#### HIGHLIGHTS FROM THE MEETING



#### ACTION \$8 MILLION AWARDED FOR HOUSING INFILL ON PUBLIC AND PRIVATE LANDS PROGRAM

In October, the Regional Council also approved funding recommendations for the Housing Infill on Public and Private Lands (HIPP) Pilot Program, an \$8 million competitive program to support scaling up the development of available land and implementing corridor-wide or area-wide infill housing policies and initiatives. The 11 awarded projects include site assessments, site inventories, inclusionary housing programs and specific plans that unlock lands for housing with diverse housing types.

The HIPP Pilot Program is part of Programs to Accelerate Transformative Housing, funded by REAP 2.0, which supports planning and implementation to accelerate infill development, affirmatively further fair housing and reduce vehicle miles traveled.

#### ACTION \$4 MILLION IN SUSTAINABLE COMMUNITIES PROGRAM FUNDING AWARDED

The SCAG Regional Council approved \$4 million in October to support 11 projects advancing multimodal communities and sustainable housing and land use strategies across Southern California. The <u>Sustainable Communities Program</u> – Civic Engagement, Equity and Environmental Justice (SCP CEEEJ), under which these

awards are issued, is funded through Senate Bill 1 for multimodal communities projects and Regional Early Action Planning program (REAP 2.0) for housing and land use strategies projects. The SCP CEEEJ prioritizes strategies that close the racial equity gap, include partnerships with community-based organizations and fund or directly benefit historically disadvantaged, underserved, underrepresented and under-resourced communities.

#### ACTION REGIONAL COUNCIL AUTHORIZES OFFICE OF TRAFFIC SAFETY GRANT FUNDING

The Regional Council approved a resolution at its October meeting authorizing SCAG to accept \$1.35 million in grant funding from the California Office of Traffic Safety (OTS). This funding will be used to continue the *Go Human* program, with plans in 2023-2024 to support localized traffic safety engagement, temporary safety demonstration projects and the distribution of Community Streets Grants across the region, as well as research and analysis to assess existing strategies and inform new ones. In addition, the Regional Council approved a second resolution authorizing SCAG to accept an \$886,000 OTS grant award to fund development of a regional transportation safety predictive modeling platform. This award will facilitate SCAG's efforts to take a more proactive approach toward the analysis and mitigation of safety risks on our regional multimodal transportation system, with the objective of reducing the incidence of collision-related fatalities and serious injuries.

# **REGIONAL UTILITIES SUPPORTING HOUSING CALL FOR APPLICATIONS OPEN UNTIL NOV. 6**

SCAG recently opened a Call for Applications for the Regional Utilities Supporting Housing (RUSH) Pilot Program. This competitive call, open through Nov. 6, will award an estimated \$35 million to projects in any of the following categories meeting the definition of infill:

- **Planning Projects**: Plans, programs and green infrastructure plans to support increased utility capacity to support residential development identified in housing elements.
- **Capital Projects**: Projects that address current and future utility restrictions for housing development and enable continued infill housing development by upgrading infrastructure for sewer, water, stormwater and dry utilities systems.

Recordings of an Oct. 4 information session will be available soon, and <u>office hours</u> with SCAG staff are available to support applicants. More information on the call for applications and technical assistance opportunities are also available on <u>SCAG's</u> <u>RUSH website</u>.

#### SOUTHERN CALIFORNIA AFFORDABLE HOUSING AND SUSTAINABLE COMMUNITIES PROJECTS AWARDED \$215 MILLION

The California Strategic Growth Council recently announced the 7th cycle of its Affordable Housing and Sustainable Communities (AHSC) program, which advances building affordable housing in walkable neighborhoods with access to jobs. As part of this funding cycle, a total of \$215 million was awarded to six projects in the SCAG region that are projected to develop more than 997 new units of affordable housing in disadvantaged communities.

Overall, this cycle of the AHSC program funded a total of \$757 million for 16 projects in California.

Every year, SCAG writes letters of support for affordable housing projects applying to the AHSC program and will continue to work with local partners to bring funding to projects in Southern California.
